

## **Village of Creston Minutes March 6, 2018**

President Williams called the meeting to order at 7:00 pm with Trustees Ward, Byro, Hopkins, Katzman, Kerns, Misch present, along with Clerk Haub.

Minutes from February 6, 2018 regular meeting were reviewed. Trustee Hopkins made a motion to accept the minutes as read, with Trustee Ward giving the second to the motion. The minutes were approved with all yeas.

**Visitors & Communication** – Erik Petry of Petry Farms presented rent bonus information to the trustees. Maria Godina approached the board in regards to her yard flooding and getting worse in the past 3 years. Mr. Bunge will take a look.

Atty. Crull has been talking to RC Pottinger in regards to the subdivision.

Trustee Byro made a motion to allow Mr. Loyd to modify the plow blade, allowing up to \$2,000. Trustee Katzman made the second to the motion. A roll call vote passed the motion with all yeas.

**Treasurer's Report** – The Treasurer's report was reviewed. Trustee Hopkins made a motion to pay the bills. Trustee Ward seconded the motion and a roll call vote passed the motion with all yeas from the trustees.
